History of October 27

- ◆ **1947** : King Hari Singh of Jammu and Kashmir accepted the merger of Jammu and Kashmir into India.
- ◆ **1920** : The headquarters of the League of Nations was shifted to Geneva.
- ◆ **2008** : The Central Government issued a notification providing interim relief to journalists and non-journalists in the newspaper industry.
- ◆ **1605** : Akbar, the third ruler of the Mughal Empire, died in Fatehpur Sikri.

Current Affairs Related to 27 October

- ◆ In the fourth Asian Para Games, India will send its largest ever contingent to the Asian Para Games 2023, to be held in Hangzhou, China from October 22-28. A total of 309 athletes, including 196 men and 113 women from India, will compete in the 4th Asian Para Games.
- ◆ India's fast opening batsman Shubman Gill has left a significant mark in the world of One Day International cricket by becoming the fastest player to reach 2000 runs in this format. This feat has seen him surpass the previous record held by South African great Hashim Amla, further enhancing his reputation as a rising star in the world of cricket.
- ◆ In a significant development for the Indian Railway Catering and Tourism Corporation, Sanjay Kumar Jain, a 1990 batch Indian Railway Traffic Service officer, has been appointed as Chairman and Managing Director. His appointment comes after the post became vacant following the retirement of Mahendra Pratap Mal in January 2021. His appointment was recommended by the search cum selection committee and later approved.
- ◆ Senior Indian diplomat Indra Mani Pandey was appointed as the Secretary General of BIMSTEC. For the first time, an Indian has been appointed to an influential post in this group. Pandey, a 1990 batch Indian Foreign Service officer, is currently serving as India's Permanent Representative to the United Nations and other international organizations in Geneva.
- ◆ Defense Minister Rajnath Singh inaugurated the Indian Military Heritage Festival which was organized by the United Service Institution of India at the Manekshaw Centre, New Delhi. In which Army Chief General Manoj Pandey also participated. The United Services Institution of India, India's oldest tri-service think tank, functioning since 1870, organized the annual Indian Military Heritage Festival. The grand occasion paid tribute to India's rich military history.
- ◆ Indian Space Research Organization has successfully tested Mission Gaganyaan Abort Mission-1. Also, the crew escape system was tested on the crew module of this mission. This test will create a platform for unmanned missions. This test will serve as a base for India's first manned space mission Gaganyaan. This test vehicle will launch the abort mission crew escape system and crew module at an altitude of 17 km.
- ◆ NLC India has set up a wholly owned subsidiary named NLC India Green Energy Limited with a focus on expanding renewable energy projects and pursuing technological innovations. Navratna public sector company NLC India has unveiled its latest venture in the renewable energy sector.
- ◆ DigiKavach Google aims to combat these fraudulent activities by understanding the strategies adopted by scammers and implementing countermeasures. Tech giant Google has taken a proactive step to address the growing concern of online financial fraud in India. Through its new program, Digi Kavach, Google aims to combat these fraudulent activities by understanding the strategies adopted by scammers and implementing counter measures.
- ◆ Defense Minister Rajnath Singh inaugurated Project Uddhav, an initiative of the Indian Army to blend ancient knowledge with modern military methods to deal with current security challenges. The Indian Army has recently launched Project Uddhav with the aim of rediscovering the deep Indian heritage of statecraft and strategic ideas derived from ancient Indian texts. Project Uddhav, initiated by the Army, aims to use ancient Indian texts such as Chanakya's Arthashastra, Kamandaka's Nitisara and Tamil poet saint Thiruvalluvar's Tirukkural to gain insights on statecraft, strategy, diplomacy and warfare.




